As ratified on May 10, 2017 by the Board of Trustees of the Los Angeles Community College District, the above-referenced agreement is hereby amended as follows:

A. PERIOD OF SERVICES:

The period of services is from March 15, 2017 to May 14, 2017, inclusive.

Any reference in the header information set forth in the upper right corner on the front page of this Agreement, to "Contract Amount" and to dates identified as "Start Date" and "End Date," specifically indicates only those provisions made, or the intent thereof, to fully fund the Agreement for scheduled payments due hereunder during the current fiscal year, and is not to be construed as a reference to the intended or actual contract period, or to the full sum of payments that have been made or are still to be made under this Agreement.



B. AMENDMENT/SERVICES:

Install and upgrade AV Systems in Automotive Technology Department, Room 3640, 3641 & 3610.

TASK: GST will supply, install and configure the following in each of these three classrooms:

- . 1 Each Spectrum Freedom One elift Instructor Station with Built-in Rack.
- . 1 Each Pierce standard PC with Utelogy software with desktop monitor, keyboard and mouse.
GST wil configure the Utelogy software to control the system.
- . 1 Each Extron AV scaling switcher.
- . 1 Each Audio amplifier
- . Speakers (Room 3610 will get 4 Each surface mount speakes, Rooms 3640 and 3641 will get 4 Each ceiling mount speakers).
- . 1 Each Blu-Ray/DVD Player.
- . 1 Each Document Camera (will not controlled by Utelogy).
- . 1 Each Aux HDMI and 1 Each Aux VGA/Audio inputs in Cable Cubby.
- . 1 Each Surge protected power supply.
- . **1 Each Epson Brightlink 697Ui Interactive Projector.**
- . **1 Each Dalite 94" IDEA Screen. No other screen or whiteboard will be supplied or installed.**

C. AMENDMENT/COST:
