Attached are the two quotes we received for the electrical work/raceway installation. One vendor did not bid (GST). As you can see Rosendin was the low bidder. They are also a company that can do the whole project in-house (Electrical, cabling, and AV). As discussed, the bond can cover the materials, but the college would have to directly cover the labor. Keep in mind this assumes that the existing electrical after the outlets are moved, will be able to support the new AV system. There is a possibility that there will need to be additional work done to isolate dedicated circuits. The load testing is included in Rosendin's quote, ACS kept it at a ridiculously high add/alt cost of \$6k per panel.
