| 6 | College Administration Report - Earic Dixon-Peters on behalf of Kathleen Burke Presented on activities in Student Services and distributed a handout with student enrollment data. Findings included: Student population - The ratio of part-time students is 78%, where most students are of traditional age (18-24 years old). From fall 2015 to spring 2016 = 7500 students lost, lost 7800 students the following year, and this year, we lost 8800 students. These numbers do not coincide with the unemployment rate in San Fernando Valley. The argument for the low enrollment was due to a strong economy. However, the unemployment rate in the nation is 4.1%, the unemployment rate in LA County is 4.1%, and unemployment rate in the San Fernando Valley is 5.8%. Enrollment Status of College Promise - College Promise efforts are successful; those students enrolled in College Promise performed better. Students were called individually and asked for feedback. Students who did not complete College Promise requirements reported that they did not feel connected to the college. There is more competition with other schools in and outside of the district now that students can attend any community college free for the first year. Therefore, we need to continue reaching out to students and provide a clear timeline of their time here at Pierce. |

- Appointment of membership to task forces. The Senate should be making appointments.
- The shared governance should meet Accreditation standards.
- The shared governance agreement should be updated.
