College Recommendation 6 (Improvement): Technology

In order to improve, the team recommends that the College include IT staff in technology planning related to building and construction to ensure appropriate and adequate technology services, professional support, and technology hardware to meet the needs of operational functions, academic programs, teaching and learning, and support services. (III.C.1)

Response:

The college is still undergoing a major renovation process that began several years ago. The completion of the North-of-Mall Phase 1 project featured the installation of the Utelogy system and supporting infrastructure, comprised of collaborative work between BuildLACCD, District, the A/V smart classroom taskforce (Technology Committee), and campus IT. The IT team was trained on the Utelogy system (implementation, operation, and maintenance) and the campus has agreed to adopt this as the model for smart classroom management moving forward. This model was also implemented in the Auto-Tech area (3600), the Library Learning Crossroads Distance Education Conference room (5160), and will be used in North-of-Mall Phase 2 (1200, 1300, 1400, 1500), and Village 8201, 8202, 8320. The IT manager and IT team members have been actively included in the planning and implementation of these projects,

working with BuildLACCD, and district IT. The college has noted how the direct involvement of IT in these areas has improved all stages of the projects and has addressed future maintenance.

The college has noted the importance of IT being involved in technology planning, as witnessed by goal 4 in the school's mission statement – "Pierce College will expand the effective use of technology in all areas of the college." (Goal 4, Mission Statement). Further, the involvement of IT members in shared governance shows this commitment – IT reports an IT Project Prioritization List to the Technology Committee and takes suggested input before final prioritization and implementation of the list. The college has noted that streamlined delivery of successfully-completed buildings technology-wise is the direct result of IT involvement in all project stages.
