The LACCD has not had an increase in student health fees in more than a decade. At the same time, the costs of both providing health services and students' needs have increased. Due to the lack of funding, many colleges offer limited hours of operation for health services, a limited scope of health services, and less than optimal mental health services. The District has evaluated the current services and conducted an analysis of health fees at local colleges, which range from \$17 to \$21 per primary semester. **The District is recommending a \$19 health fee in Fall and Spring and a \$16 health fee in Winter and Summer which reflects current cost at surrounding Districts.** This increase will result in approximately \$2.9 million additional funding annually, which can only be used to support student health services. The Student Affairs Committee voted to support this proposal at their January meeting.

**Enrollment and SCFF Update**

**1. Winter Enrollment**

As of **Day 10** of the Winter semester [comparing Winter 2020 (1/16/20) to Winter 2019 (1/12/19)] for the District:

- Credit Headcount is 13% higher
- Duplicated Enrollment is 14% higher
- Section Count is 6% higher
- Enrollment per Section is 7% higher

**2. Spring Enrollment**

As of **Day -25** of the Spring semester [comparing Spring 2020 (1/16/20) to Spring 2019 (1/10/19)] for the District:

- Credit Headcount is 11% higher
- Duplicated Enrollment is 10% higher
- Section Count is 1% higher
- Enrollment per Section is 8% higher

**3. 2019-20 Annual FTES Projection**

Based on the most recent class schedules and enrollment and attendance accounting data, the District is projecting an increase of 0.3% to 0.7% (300 to 700 FTES) over 2018-19 FTES (98,139). Enrollment projections will be discussed and confirmed with the colleges at the upcoming 2nd Quarter Budget and FTES Meetings.

**4. Chancellor's Leadership Retreat: Enrollment Management**

College enrollment targets for 2020-21 were discussed presented and discussed the Chancellor's Leadership Retreat (held on Jan. 9-10, 2020). On the basis of data and analysis, targets were developed for each college and individual SCFF component (Credit FTES, K-12 FTES, Noncredit Regular FTES, and Noncredit Enhanced FTES). The targets were presented at the retreat, and colleges engaged in an interactive working session, examining recent enrollment data and discussing the capacity, resources, and strategies needed to attain the targets. Based on feedback from the colleges and review by the Chancellor, targets will be available in late-Feb. 2020.

#### **B. NetTutor Update**

- Data includes sessions from August 23, 2019 to January 10, 2020
- 2,503 (unduplicated count) students used the software within this timeframe
- Session times ranged from 1 minute to 4 hours and 12 minutes; average time is 22 minutes per session
- 8,743 sessions have been logged
- Approximately 3,244 hours of tutoring have taken place
- 62% of tutoring sessions were for math

- 34% of tutoring sessions were for English and Writing
- Planned analyses will integrate this data with student outcomes
