Students who had received financial aid for Spring 2012 and then dropped out must return the money. If they do not, the college is liable by law for those funds and must repay the federal government. The remaining college indebtedness for Spring 2012 is \$50,800, which must be paid by June 20. Joy stated that we have collected \$50,000 back so far this year from the students, and we will keep working to collect this balance. It was noted that the college has given out \$42M in financial aid this year.

VI. ACCREDITATION SELF-EVALUATION REVIEW- STANDARD II—Donna Mae Villanueva/Crystal Kiekel (handout)

Crystal spoke on Standard IIA, High-Quality Instruction. She gave four key points to summarize what Standard IIA is all about:

- 1. High-Quality Instruction. Standard IIA is about the extent to which we provide high-quality instruction—the extent to how our programs reflect our mission statement, the extent to how our programs provide depth and rigor of whatever concept we are trying to teach, whether or not our staff is addressing the learning needs of students. Students with special needs, students that have different strengths—we are supposed to be assessing the extent to which students have special needs and the extent to which they are learning and able to thrive in the classroom. Based on these assessments, Standard IIA is looking at how we use appropriate modes of instruction. If our students have special needs, are we addressing them?
- 2. The Extent to How Our Programs Leads to Completion. We are not only looking at success, but we are also looking at completion for our students as a goal for our college. Are we providing a well-rounded general education curriculum? Are we providing current technical education programs that actually lead to certificates and jobs? In our general education programs, are we offering articulated courses that students can use to be able to move on to a university?
- 3. Systematic Assessment. That is where those SLOs come in. To what extent are we assessing the currency of our programs? Are we offering programs that are no longer relevant? Or, are we offering programs that really address the here and now and are we updating those programs regularly? Are our
